- I do hereby release, indemnify, and hold harmless the Thailand Equestrian Federation (TEF), the Royal Stable Unit (RSU), the Royal Horse Guard (HG), the Organizer and Sponsors, all their Personnel, Staff, Employees, Management and Volunteers, their Agents, Representatives, Members, Directors, Officers, Partners, Instructors, Helpers and other Guests, Visitors and Spectators, from any and all liabilities, obligations, damages, demand of compensations, claims, any form of litigation or legal action, from any and all injuries sustained, from any and all accidents, from any and all loss of property and damages, and from any and all unforeseen and foreseen incidents, that occur or happen not only to my Son/Daughter/Ward, but also to any other guest and family members accompanying him/her at the event, as a result of his/her participation in the FEI CSIJ-B in 18 - 21 November 2022, at the Royal Stable Unit and the Royal Horse Guard, Bangkok, Thailand.
