Scoring: During the cross country phase in Class 9, penalties for disobediences and a time quicker than 15 second under the optimum time or a time exceeding the optimum time will be added accordingly to Art 432. In case of equal penalties, the classification method is based on art 403.

### **1. Liabilities**
