In order to be the Individual ranking per country, per Region and the world for 3 Categories, an athlete/horse combination must complete in a Minimum of Two Competitions.

Only the results of the best Two Competitions per Category will be counted for the rankings.

VI. PARTICIPATION

Number of entries	Minimum 1 per class
Number of horses per rider	Maximum 2 per class

- **Horses cannot be ridden by more than one rider in one Category throughout the FEI World Jumping Challenge during the same year.**
- Competitors may ride more than one horse in a category but the score of only one horse will count for points, this horse must be declared before the first competition. The results obtained with the other horses will not count towards the final standings. The rider must complete the official FEI Declaration Form and return it to the HKEF by fax (Fax No.: 2966 5082), email (E-mail address: jack.siu@hkef.org) or post (8/F., Central Complex, HKJC Shatin Race Course, Shatin, Hong Kong) on or before 1 Nov 2017.
- **In case an athlete is riding more than one horse, the declared horse must be ridden first in all rounds.**
- Athletes having participated at CSI* events (this includes Senior Regional/Continental Games & Championships/WEG/OG) in classes at 1.35m and higher are not allowed to compete.
- An athlete that has NOT completed at the above mentioned level **more than 3 years** is allowed to complete in the FEI World Jumping Challenge again.
- Any rider that has competed in the Youth Olympic Games is eligible to compete in the FEI World Jumping Challenge

VII. ENTRIES

Entry Cancellation – Entries cancelled after closing time must be verified with a Veterinary Certificate or Medical Certificate, otherwise Entry fee will not be refund by the OC.

VIII. OTHER REGULATIONS

1. Liabilities

All athletes will participate in the Event under their own risk. Their participation confirms their acknowledgement that in case of an accident during the event or a training session they disclaim the enactment of any civil rights which may arise against other athletes participating in the event or the training session.

The HKEF are not responsible for the following liabilities:

- Any injuries, diseases, and accidents to the horses, athletes and officials in the time of transportation and during the competition period.
- Any loss or damages to any third party caused by the participating riders and horses in the time of transportation and during the competition period.

2. EVENT'S ORGANISATION (HKEF Rules Art. 101)

The OC reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances. All modifications made to the schedule prior to the event must have the approval of the President of HKEF (or his authorized representative). Modifications during the event may only be made by the Ground Jury.
